Guidelines for the conduct of Online Open Book Examination:

1. The Examination shall be held in online mode .
2. The question paper will be floated through Whatsapp by the Convener, Board of Studies of Education , University of Jammu to the Principal of the concerned Colleges and the Principal/s will share the question papers with the students (Regular and Private) of their respective colleges .
3. The College Principal will create a separate dedicated mailbox and the students shall after due time submit the Answer Scripts to the dedicated mailbox of the concerned Principle in compressed PDF format within 15 minutes after the completion of the paper.
4. The E- mail address shall be notified by the respective Principal's to the students.
5. The students shall have to write the answer on A4 size white sheet only.

6. The students will write on the front page of Answer Sheet- Name , Parentage , University Roll No. and Session Course Code , Title of the course , No. of sheets used (the sheets shall be numbered from 1 onwards) & Signature . At no other point/place , the student will disclose his/ her identity by writing the name , signature or Roll no. which shall be tantamount to the use of unfair means and will be penalized under the unfair means statutes of the University of Jammu.
7. The candidates are advised not to write on the backside of the first page of the answer sheet .
8. In case of failure to uploads the compressed PDF format , the students are advised to send a screenshot of failing to upload the PDF file and the efforts should be on to submit the file up to half an hour (This includes 15 minutes extra given to such students) on the day of examination by the students .
9. No PDF file/hard copy shall be entertained from the students directly by the University. The local students (students living within the limits of J&K UT) will submit the hard copy of their Answer scripts to their respective Colleges by hand . The outstation students (students living outside the limits of J&K UT) will send their Answer Scripts by Speed Post to their respective Colleges . The Principals of Private Colleges/ Rector Bhadarwah campus/ Director/Coordinator D.D.E should deposit all the hard copies of the Answer Scripts along with the Memo and downloaded PDF file received from the students of their respective colleges in a Pen drive to the Evaluation Section Examination Wing, University of Jammu not later then 07/10/2021 for the Evaluation Process. The outstation students should dispatch all (all papers in which they have appeared) Answer Scripts in one packet immediately after the completion of the Examination i.e 27/09/2021 properly scaled and have proof that they have dispatched the packet of their Answer Scripts before the due date .
10. The students who send their Answer Scripts by post shall be reimbursed postage charges subject to the production of postage receipts and enclosing their NEFT form for the same .
11. There shall be no provision of re-evaluation in the Online Examination.
